- 3. After opening technical specifications, the committee may call all the successful tenders for demonstration of stated claim.
- 4. The equipment must include the specified warranty/guarantee period, and the AMC for one year is mandatory and must be FOR Vety and Livestock Innovation and Incubation Foundation, Guru Angad Dev Veterinary & Animal Sciences University, Ludhiana.
- 5. A valid GST number and the HSN code of the product must be mentioned on the quotation.
- 6. The rates of the items must be quoted with all the terms & conditions and must be FOR Vety and Livestock Innovation and Incubation Foundation, Guru Angad Dev Veterinary & Animal Sciences University, Ludhiana destination basis, including all taxes and charges, such as insurance, customs duty against the Custom Duty Exemption Certificate, clearance, and transport charges (if applicable).
