Terms & Conditions:

1. The technical proposal should detail the complete specifications and compliance with tender requirements, while the financial proposal should provide a detailed cost breakdown, including the cost of equipment, installation, commissioning, and the AMC, inclusive of all taxes and duties.
2. The technical proposals will be evaluated first, and only those that meet the specified requirements will have their financial proposals opened for consideration.
3. The equipment must include the specified warranty/guarantee period, and the AMC for one year is mandatory and must be FOR Vety and Livestock Innovation and Incubation Foundation, Guru Angad Dev Veterinary & Animal Sciences University, Ludhiana.
4. A valid GST number and the HSN code of the product must be mentioned on the quotation.
5. The rates of the items must be quoted with all the terms & conditions and must be FOR Vety and Livestock Innovation and Incubation Foundation, Guru Angad Dev Veterinary & Animal Sciences University, Ludhiana destination basis, including all taxes and charges, such as insurance, customs duty against the Custom Duty Exemption Certificate, clearance, and transport charges (if applicable). The supplier will be responsible for clearing the item from the customs department and delivering it to the VLIIIF, if applicable.
6. Rates quoted must be valid up to 90 days. In case prices are reduced or any other benefit (in the form of a lower price, lower tax, favorable foreign exchange rate, etc.) arises, it must be passed on to VLIIIF.
7. Incomplete technical and financial quotations, without brand name, or received after the due date/time shall be rejected forthwith. VLIIIF does not take any responsibility for any postal delay in delivery by Registered/Speed Post or loss in transit of the quotation.
8. Conditional and unsigned quotations will not be accepted.
9. The delivery period for the items must be clearly stated in the quotations. No further correspondence regarding this will be communicated by VLIIIF.
10. The quotation shall not contain corrections, erasers, or overwriting, as this will result in rejection of the quotation straightaway.
11. VLIIIF reserves all the rights to accept or reject any/all quotations and to increase or decrease the quantity or configuration of items specified, without specifying any reason. No correspondence will be made on this matter.
12. A valid authorization certificate issued by the manufacturer must be attached with the quotation.
13. The quantities mentioned are tentative and can be increased/decreased to any extent or can be totally omitted according to the sanctioned amount, and the firm will have no claim on this account.
14. If the date of opening of quotations is declared a public holiday, then the quotations will be opened on the next working day at the same time. The terms & conditions will remain the same.
15. The standing committee will open the financial quotations of only those firms whose technical quotations are found to be in order.
16. In case of any dispute, jurisdiction will be Ludhiana District Courts.
